High quality, durable stencil coated with an advanced, medium tack, rubber-based pressure-sensitive adhesive protected by a clear PET liner. The 15" width will track and process on both IBM® and Gerber® pattern cutters. The 30" width will fit only Gerber® #750 plotter machines. Tractor-feed holes are punched through liner and rubber. The specially treated polyester liner retains cut designs during transfer from plotter to stone.

Single-process and double-process media blast carving of granite or marble. Replaces #790Y in Gerber® plotter applications.
